COLORATURA SOPRANO: A singer who has great trouble finding the proper note, but who has a wild time hunting for it.


# RICH CAPPARELA HEADLINES CRESCENDO

Under the planning direction of COPW member, Mary Beaudry, 100 youth will be attending LA Phil of COPW. concerts courtesy Maryvale Youth Home, Five Acres home for Youth. Sycamore/Hathaway House will select children from their residential population to attend one of the youth concerts being offered by the LA Philharmonic this year. The youth residing in these state licensed group facilities are foster children who have been removed from their homes for a variety of serious reasons.

Being able to attend a concert is not oridinarily available to any of these children. Mary has received very favorable feedback from the instituitions who participate in this program with us. A child who attended last year, had never heard a live performance before, and was so impressed that she returned to school and enrolled in the school band. Mary will be recommending to COPW that we continue this charitable program again next year.



# LA PHIL REQUESTS \$ FROM COPW

Recently the Los Angeles Philharmonic Association communicated to COPW indicating that we would have new financial goals for 2012-2013:

LA PHIL Contribution \$7,000

Philharmonic Friends \$14,000

For the past three years, COPW has contributed \$5,000 annually to the Phil. Last year we contributed over \$14,000 the Philharmonic to Friends. The increases requested by the staff are small. But since we are not primarily a fund raising group, I and Colleen Robertson and Elaine Berman met with Stephanie Wells, our mentor from the LA Phil Development office on January 5. She was very supportive of COPW and appreciated our past efforts. She noted our instrument drive as a significant contribution.

She indicated that the Phil would assist us this year by contributing items for use in a silent auction and prizes that would help us raise money to meet our goals. She also stressed that the Phil understood that we were not a fund raising group and that there would be no sanctions if we were unable to meet the goals set for us.

At this point it seems more like a PHIL formalization of contribution plans for COPW that have been pretty much in place for a number of years. Your board will report to you if there any significant changes in this area.
